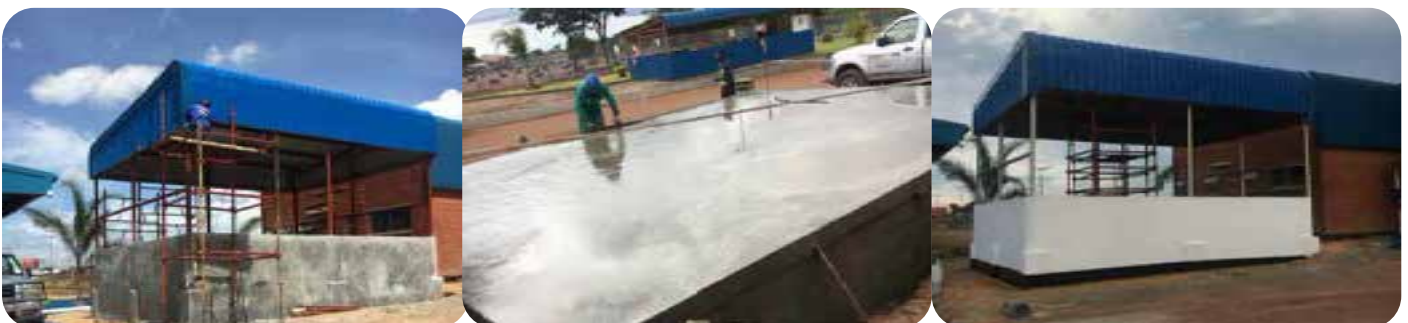

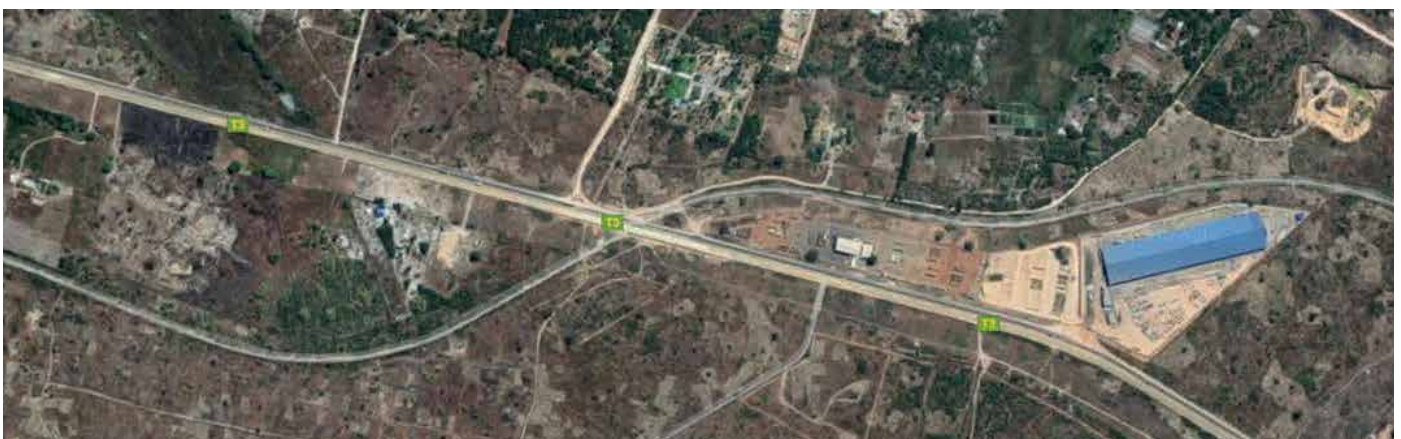
Distribution

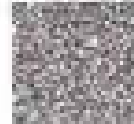
